COOPER TIRE OFFICIAL REBATE TERMS AND CONDITIONS:

1. This offer is open to legal residents of the 50 United States, the District of Columbia and Canada (excluding Quebec), making purchases in those locations. The rebate offer is not transferable and is valid only for the individual who purchased the product for personal household use. Void in Quebec and where restricted or prohibited by law.
2. U.S.: Approved claims in the United States of America will receive the rebate in US dollars in the form of a Visa® prepaid rebate card, to be mailed to the address provided on this Official Mail-in Rebate Form. Rebate card is issued by JP Morgan Chase pursuant to a license from Visa® U.S.A. Inc. The card requires activation by the recipient and can then be used at any location that accepts Visa® cards. The card cannot be used for cash withdrawal at an ATM. *Bank fees on the card are waived for the first 90 days following date of issue. After that time, a \$3.95 monthly bank fee will be applied by JPMorgan Chase against the remaining funds on the card.* The card will arrive attached to a card mailer. Rebate requests must be postmarked no later than December 8, 2011 and received at the rebate fulfillment center no later than December 23, 2011. Late submissions will not be accepted.** Allow 6 to 8 weeks for delivery of the VISA® prepaid rebate card.

9. Keep copies of all documents for your records. Disputes will require copies of all submitted materials for verification. Please allow 6-8 weeks after Sponsor receives the rebate request for the delivery of your Visa® prepaid rebate card or check.
